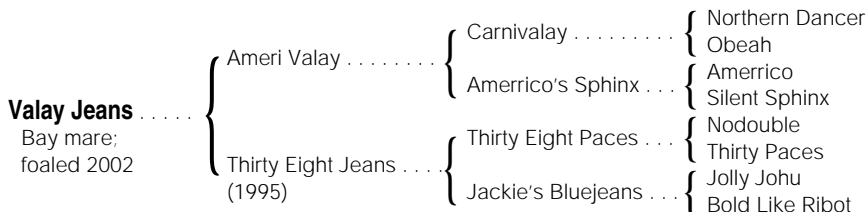

Bold Like Ribot, by Bold Monarch. 6 wins, 3 to 6, \$59,755, 3rd Ocean City S. Dam of 4 other foals to race, 3 winners--

JOLLY JACKIE. 3 wins at 3 and 4, \$68,274, Sagamore Farm Maryland Starter H. [LR] (PIM, \$30,000), 2nd Caesar's Wish S. [LR] (PIM, \$11,240). Dam of 3 winners--

Bold Like Ribot. Black type-placed winner, see above.

Regally Royal. 2 wins at 3, \$14,772. Producer.
