# Labeling X-rays

**ALL X-RAYS MUST BE IN DICOM FORMAT ONLY**

## REQUIRED VIEWS

### AAEP Minimum Required Views

To accommodate viewing-sort order, all hips must be submitted with the anatomical/view information. You may have to contact your equipment representative to arrange this formatting.

## LABELING

It is important to label your study as accurately and completely as possible so that Keystone Asteris can recognize them.

## OVERLAYS

Please export your studies **WITH burnt in overlays on images**. Our DICOM viewing software has the option to toggle the most relevant tags on/off when viewing. In addition, there is a button to view all tags. When submitting a set of x-rays, please be sure to complete the **Accession Number/DICOM Tag Requirements and a combination of the SALE CODE and the HIP NUMBER in a 4-digit format**.

**THE PATIENT I.D. IS A COMBINATION OF THE SALE CODE AND THE HIP NUMBER. PLEASE SEE THE CHART BELOW FOR SPECIFIC SALE CODES.**

## **REPORTS AND DOCUMENTS**

ALL REPORTS AND DOCUMENTS MUST BE SUBMITTED **INDIVIDUALLY** AND IN **PDF FORMAT ONLY!**

These documents should be submitted along with x-rays when possible, and at least four (4) days prior to the start of the sale.

Please take your time submitting documents to Asteris. It is important to make sure documents are placed in the correct place. If Asteris will not allow you to submit a document, it is very likely that there is already one submitted.

### **X-RAY REPORTS**

All x-rays submitted to the repository must be accompanied by a veterinarian's x-ray report. The **Veterinary Report of Radiographic Findings (X-ray Report)** must disclose the attending veterinarian's ownership interest in the subject horse, if any. Once reviewed by Fasig-Tipton, the x-ray report will be electronically stamped with a date and time. It will then be available in the client portal. [This report is not available for review in the Repository.](#)

### **SCOPE REPORTS**

We strongly encourage submitting a scope report, but it is not required unless the report discloses a problem.

### **MEDICATION SHEETS**

We encourage consignors to fill out Medication Sheets on any racing prospects.

### **SALE DAY MEDICATIONS**

All NSAIDs or Corticosteroids administered after 6:00pm the day before a sales session must be submitted in writing to the Repository.

### **BREEDING SOUNDNESS EXAMS**

Breeding Soundness Exams do not get submitted to the Repository.

**ANY MEDICAL DOCUMENT THAT IS NOT HANDED IN BEFORE SALE DAY WILL BE ANNOUNCED FROM THE SALES RING.**

## **ENDOSCOPIC VIDEOS**

**ENDOSCOPIC VIDEOS ARE NOT REQUIRED, BUT THEY ARE STRONGLY ENCOURAGED.**

**The videos must be performed no earlier than 10 days from the day of sale.**

Please clearly type, write or show the horse I.D. and the date the video was taken at the beginning of the video. Using the catalogue page or stall card works great. Please make sure the video is clear. If we can't identify these things on the video, we will be contacting you for a document to ensure the horse is identified correctly. **We do not use the microchip number to identify the horse.**

Supported file types: \*.asf, \*.avi, \*.mov, \*.mp4, \*.mpeg, \*.mpg, \*.wmv

Recommended file size: There is a 100MB limit to video file size. For ease of viewing, it is recommended that file sizes be kept within reason.
