CREDIT & AGENT INFORMATION

UNITED STATES RESIDENTS

Unless credit has been established with Fasig-Tipton Company, Inc. or its subsidiary at least five (5) days prior to sale the terms shall be cash at the time of sale. Payment will be accepted in the form of U.S. currency, certified check, cashier's check or travelers' check.

NON-RESIDENTS

Arrangements for purchased by non-residents must be approved by Fasig-Tipton Company, Inc. or its subsidiary at least five (5) days prior to sale. Payment will be accepted in United States Currency, Official Bank Check issued by an accredited United States Bank, payable in United State Currency, or irrevocable sight letter of credit confirmed by J P Morgan Chase Bank.

This irrevocable sight letter of credit must specifically provide that payment is to be made at sight upon presentation by Fasig-Tipton Company, Inc. or its subsidiary to J P Morgan Chase, Lexington, KY of (1) invoices for each and every horse purchased showing full purchase price, inclusive of sales tax and other charges, as applicable (2) executed copy of Fasig-Tipton standard business form "Acknowledgement of Purchase."

WIRE TRANSFERS THROUGH FEDERAL RESERVE SYSTEM

To facilitate settlement for purchased, U.S. funds only may be wire transferred. Transfers must indicate they are for the account of Fasig-Tipton and should show purchaser's name and hip numbers for the horses in question. Please call (859) 255-1555 to make arrangements.

AGENTS
