STABLING: Stalls will be available for horses to start shipping in Saturday, May 7th. Please use entrance off Timonium Road. Upon arrival please check with the Stable Office for stall assignments.

FEED & BEDDING: Initial bedding of 2 bales of straw will be provided. Straw is the preferred bedding for use. If you plan to bed on SHAVINGS please notify us immediately. *NOTE: No Shavings, trash or baling string can go into the muck pits.* Orders for hay and straw will be taken through the stable office. PAPERWORK REQUIREMENTS-Please check the Fasig-Tipton Client Portal for a summary. Digital Certificates, Coggins, & EVA are due **4/25/22**. Please also provide Workers Compensation / General Liability Insurance by *4/25/22*.

CONSIGNMENT CONTRACT: All signatures must be on file prior to the sale of horse(s). Authorization of Agent forms are available on our website.

DIGITAL FOAL CERTIFICATES: Assign all Registration Certificates to Fasig-Tipton Co. (All Sales) through The Jockey Club Registry. Certificates on file from previous Fasig-Tipton sales will transfer to current sale.

E.I.A. (**COGGINS**) **CERTIFICATE:** All sales horses and ponies must have an individual form dated within six (6) months of the sale stating that the horse in question has tested negative to the E.I.A. or AGID test.

EQUINE VIRAL ARTERITIS (EVA):All sales horses are required to provide an EVA Test on file dated within ninety (90) days of sale. Although this is not a warranted condition to buyers, any horse which tests positive will be listed as such at the sales office.

PIROPLASMOSIS: All horses and ponies entering the Maryland State Fairgrounds FROM TEXAS ONLY must be accompanied by a negative test for Equine Piroplasmosis showing negative results for both BABESIA CABALI and THEILERIA EQUI reported twelve months from the date of entry to the sales grounds.

HEALTH CERTIFICATES: *ALL* horses and ponies must provide a current official health certificate or certificate of veterinary inspection (CVI) which has been signed and dated by a licensed veterinarian, and which shall contain the following written statement: "All horses listed on this certificate of veterinary inspection (CVI) have not originated from or not been stable on a premises which has had herpes virus (EHV-1) diagnose during the previous thirty (30) day period."

EHV-1: All horses and ponies must provide proof of vaccination against equine herpes virus type-1 (ehv-1) by a licensed veterinarian within the minimum of seven (7) days and a maximum of ninety (90) days prior to entry. The health certificate or certificate of veterinary inspection (CVI) shall also indicate the date of vaccination and the specific vaccine product used to vaccinate each horse.

Health Certificates can be turned in at the Stable office upon arrival!

A \$100 late fee per document will be assessed if either the Digital Registration Certificate, Coggins, or EVA is received after the due date 4/25/22.

Please make sure the certificate covers the current year. A certificate from 2021 WILL NOT be accepted.

The Maryland State Fair & Agricultural Society Inc., 2200 York Road, Timonium, Maryland 21093 must be listed as certificate holder on the Certificate of Liability Insurance and Workers' Compensation.

It is recommended that you email (athorp@fasigtipton.com) or fax (410-392-5556) the certificate to Fasig-Tipton by April 25th. Please bring a copy with you when shipping into the Maryland State Fairgrounds.
